The City of Lyndon and/or Eventualities (event producer) reserves the right to reject any application, items for sale or displays that do not meet the expectations or standards of the festival.

Vendor booths **MUST** remain open during all Festival Hours- **NO EXCEPTIONS**

All vehicles must be moved to general parking area no later than 3 PM on Friday.

The following items and exhibits are **PROHIBITED**: fortune tellers, tattoo artists, body piercing, sexually suggestive items or any type of gambling or gambling devices which require licensing by the Kentucky Gaming Commissions, casino games, pull tabs, etc. Free “register to win” is acceptable. **GUNS OR TOY GUNS OF ANY KIND ARE STRICTLY PROHIBITED**

Each Vendor is responsible for collecting and paying Kentucky Sales Tax.

24 hour security will be provided beginning Friday, June 14, 2019 at 3:00 PM and ending Saturday, June 15, 2019 at 11:00 PM. The City of Lyndon and/or Eventualities makes no guarantee and assumes no responsibility for loss, breakage, etc. Items should be removed at closing or packed away and sufficiently covered.

Vendor/Exhibitor agrees to hold Lyndon's Summer Festival, The City of Lyndon, and Eventualities and agents and employees thereof harmless from any liability, loss, or damage.

Each space is 10' x 10' provided and is located in a grassy area. The space is the only thing provided. Bring your own covers, tables, chairs, etc.

Cancellation Policy- If the cancellation of a Vendor booth is desired, Eventualities must receive in written request before May 15, 2018 and vendor will be refunded 50%. No refunds will be provided after May 15, 2018.
